

**FIRST AMENDMENT TO THE SERVICES AGREEMENT BETWEEN THE CITY OF
SAN DIEGO AND BIZODO, INC. DBA SEAMLESSDOCS TO PROVIDE AUTOMATED
FORM DIGITIZING AND DISTRIBUTION SOFTWARE AND SUPPORT SERVICES**

This First Amendment to the Agreement between The City of San Diego and Bizodo, Inc. dba Seamlessdocs to provide Automated Form Digitizing And Distribution Software and Support Services (First Amendment) is made and entered into by and between the City of San Diego (City) and Bizodo, Inc. dba Seamlessdocs (Contractor), also referred to individually as "Party" and collectively as the "Parties."

RECITALS

1. City issued a Request and Certification Memorandum for a Sole Source Procurement No. 3681 that was certified by by the Director of Purchasing and Contracting on January 22, 2016, resulting in a contract between the City and Contractor (Contract). The Contract is comprised of the Contract and its Exhibits (collectively, "Contract Documents"). These documents together contain all the terms and conditions of the Contract between City and Contractor.

2. The Contract may be amended by written agreement executed by duly authorized representatives of both Parties.

3. The Parties wish to amend the Contract to increase the not to exceed amount to a total of \$350,000 , while otherwise keeping intact the same terms and conditions.

TERMS

1. The first sentence of Article III, Compensation, Section 1 is modified to read in full as follows: "City shall pay Contractor for the goods and services provided in accordance with this Contract in an amount not to exceed \$350,000. Contractor is not obligated to provide goods or services in excess of this amount, and does so at its own risk, unless this Contract is amended in writing and duly executed by City and Contractor increasing this not to exceed amount.

2. Exhibit E (Pricing Schedule) to the Contract, Section B, Table 3 is amended, in whole, to reflect the additional contract years as shown in Attachment A to this document.

2. This First Amendment will be effective when signed by both parties and approved by the City Attorney in accordance with Charter section 40.

3. All provisions of the Agreement not addressed in this First Amendment remain in full force and effect.
