WHEREAS, the San Diego Housing Commission has requested that the City convey a parcel of City-owned property, consisting of approximately 4.94 acres, located in the area of Famosa and Nimitz, to the Housing Authority of The City of San Diego so that the site can be most expeditiously utilized for the development of approximately 78 units of low-income rental housing; and

WHEREAS, approximately .53 acres will be dedicated as right-of-way as a condition of the final subdivision map; and

WHEREAS, the conveyance of said parcel to the Housing Authority will further the City's efforts to provide low-income housing opportunities for City residents; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and the City Clerk are hereby authorized and empowered to execute a Grant Deed conveying all of the City's interest in the property located in the area of Famosa and Nimitz, as more particularly described in said Deed, a copy of which is on file in the office of the City Clerk as Document No. RR-254594, to the Housing Authority of The City of San Diego, for the purpose of utilizing said property for the development and operation of rental housing units which are to be available to persons and families of low-income.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized and directed to transfer \$236,500 from the Low-Income Housing Capital Outlay Fund 30249 to Capital Outlay Fund 30245, and to transfer \$236,500 of sales tax revenue to Housing Authority Fund 10228.

BE IT FURTHER RESOLVED, that the payment of \$236,500 from Housing Authority Fund 10228 is hereby authorized in compensation to the Gas Tax Fund for that portion of the above-described site which was acquired with Gas Tax Funds.
